Renewal Requirements

Managing Brokers who were licensed prior to February 1, 2021:

You must complete 24 hours of CE between May 1, 2021 and April 30, 2023. These 24 hours must include a 12-hour Broker Management CE course, 4 hours of Core CE, and 8 hours of elective CE that includes one hour of sexual harassment prevention training.

Managing Brokers who were licensed between February 1, 2021 and January 31, 2023:

Requirements for brokers first licensed between February 1, 2021 and January 31, 2023 are based on when you completed your Managing Broker Pre-License Education.

If you completed your Managing Broker Pre-License education prior to May 1, 2021, you must complete 24 hours of CE between May 1, 2021 and April 30, 2023. These 24 hours must include a 12-hour Broker Management CE course, 4 hours of Core CE, and 8 hours of elective CE that includes 1 hour of sexual harassment prevention training.

If you completed your Managing Broker Pre-License education after May 1, 2021, you must complete 12 hours of CE between May 1, 2021 and April 30, 2023. These 12 hours must include a minimum of 4 hours of Core CE and 8 hours of elective CE that includes 1 hour of sexual harassment prevention training.

Managing Brokers who were licensed after February 1, 2023 - You do not need to renew your license in 2023. Your license renewal deadline is April 30, 2025.
